# Community Health Assessment (CHA)



- Collaborative and systematic approach
- Common understanding of community's health
- Guide investments and health improvement needs
- Assess community assets



# CHA Elements

- Demographic information
- Health status and health needs of diverse populations
- Health indicators – leading causes of disease, injury and death in Oregon
- Health indicators – leading drivers of health care costs
- Health and socio-economic disparities
- Community assets
- Stakeholder engagement

# Community Health Improvement Plan (CHIP)



- Strategies to address prioritized CHA findings
- Evidence-based community and/or clinical preventive approaches

# CHIP Elements

- Community interventions including policy changes
- Quality improvement for health care access
- Patient engagement
- Management role of patient-centered primary care team
- Workforce development
